ALLEYES ON SOUTH BELFAST ELECTION

With just days to go bookies make Hanna the favourite

BOOKIES have made the SDLP's Claire Hanna favourite to become South Belfast's next MP.

With under a week until voters go to the polls Ms Hanna is the clear frontrunner with odds as low as 1/5.

Outgoing DUP MP Emma Little-Pengelly has been tipped to lose the seat with major bookies providing odds between 6/1 and 13/2 for her to be returned as MP.

The Alliance Party's Paula Bradshaw, who is sitting at 5/1 with most major bookies,

has also overtaken Ms Little-Pengelly in the stakes.

The SDLP is expected to be the main benefactor of Sinn Féin's decision to step aside in the South Belfast seat when voters go to the polls on December 12. **Continued on page 4**
