

# EN'S STAFF WALK OUT

#### BY MICHAEL JACKSON

14 DAYS of strike action by staff at Queen's University got under way this week.

Workers took to the picket line at the gates of the university on Thursday at the beginning of a series of strikes in a long-running dispute over pay and pensions.

The University and College Union says it has the support of both staff and students in the face of what it claims are efforts by universities to disrupt the action and confuse the issue. The union went as far as to accuse universities of bribing staff in an effort to get them to call of their coming strike actions.

Meanwhile, Queen's says the university will remain open during the strikes and that "every reasonable effort" would be made to ensure that students are not disadvantaged by missing out on lectures.

A number of single strike actions are due to take place before a week's walk-out scheduled to begin on March 9.


